Carolyn and Jim will bring handcarts. Susan will bring a table. The following are possible outlets for information about the sale: Cable TV, Modesto Bee, and radio stations Rock 96, Sunny 102.3, B93 [92.9], and KAT Country. There are hundreds of plastic bags in the cupboard. Roz will bring 100 membership forms to go into the bags. Set-up for the sale will be Thursday, April 29, from noon until 6 or whenever we are done.

Jim checked with the Stanislaus Foundation about the reimbursement to FOEL for the supplies for the Halloween party. He has resubmitted the invoices as the original request had been misplaced.

Friends groups have been asked to help pass the library funding tax, which expires in 2012.
