President Christine Brereton introduced the guest speaker, Amanda Hughes of the Stanislaus Community Foundation.

Amanda gave a most informative presentation on the Stanislaus READS! project. Its purpose is to focus on the need to increase the percentage of students reading at grade level by Grade 3 because in Stanislaus County 71% of students enter third grade below grade level.

She gave examples of participating agencies' efforts to promote early childhood literacy such as the Pop Up Library, summer reading programs at the Stanislaus County Library branches, and Imagination Library in the five target schools Stanislaus READS! is serving.

Christine introduced herself and welcomed everyone.
