She was active on the board with ten different FOTPL presidents and four different Turlock Library Branch Managers.

Susan has been co-chair of FOTPL book sales from 1997 to the present. She has sorted books, designed and produced posters and postcards to advertise the sale, secured equipment and presided over volunteers working during the

sale. She also maintained the membership database for many years.

In 2010 the Stanislaus Library Foundation gave Susan the Shining Star Award for her contributions to the Stanislaus

#### ABC PROJECT GRADUATION PROGRAM

"I've read that book!" was what one child had to say while looking at a book display of some of the children's book titles that the ABC Project sends to local children on a monthly basis as part of the Dolly Parton Imagination Library program for children's literacy. He was attending a program held at the Turlock Library on March 23, 2013, as a graduation celebration and story time for the children who have reached the age of five and are no longer eligible for the monthly book giveaway. The intent of the program was to show the children that there are other wonderful and interesting books to read and that one of the best places to find them is at the local library!

We had a short story time with books about puppies (*Please, Puppy, Please*, by Spike and Tonya Lee, and *The Pigeon Wants a Puppy*, by Mo Willems), and a fun song with a scarf activity. There was also an exhibition of a variety of library materials and time for some questions about the library and

getting a library card. Several children had not been to the library before, and their parents signed them up for their first library card. The response from both parents and from Dr. Susan Neufeld, ABC Project Director, was very positive.

The Turlock Friends of the Library funded snacks for the program and a ribbon award for each of the eight "graduates." The library hopes to continue to work in partnership with the ABC Project to host many more future graduation programs on a quarterly basis!

# **Shining Star Award**

HyPower Hydraulics of Turlock has been a brightly shining star in the Turlock Library support system for many years. Without the help of its owners, manager and staff, the Friends of the Turlock Public Library would have found it difficult, if not impossible, to have developed their large-scale annual book sale.

When this effort began more than a decade ago, the FOTPL Board was seeking free space for storing donated books until the annual book sale. Vivian Manha, a member of the Turlock Friends group and also a member of the family that owned HyPower came to our rescue. HyPower had just moved into its new buildings at 1240 S. First Street and luckily had extra space to offer. Vivian arranged a partnership which has grown and benefited our Turlock Library immeasurably.

Over the years, manager Konrad Hack has spearheaded HyPower's efforts on our behalf. He has released members of his staff from their duties so that they could help us as needed. After boxes are sorted and loaded onto wooden pallets, staff members shrink wrap the pallets, then forklift them to the storage area. The books are stored for a year and loaded onto pickup trucks for their trip to the sale area.

These are some examples of HyPower Hydraulics' and Konrad Hack's willingness to go above and beyond in helping the Friends, and hence the Turlock Library. We, the Friends, wholeheartedly support recognizing HyPower for their steadfast support of our annual book sale.

## **Proposed Changes to the Friends of the Turlock Public Library's Bylaws** (Note: old text has been marked out; new text is underlined and in bold.)

ARTICLE VI: ELECTION AND TERMS OF OFFICE

Section 5: The term of office shall be one year and shall begin at the close of the annual meeting beginning the month following the annual meeting. No member of the Board of Directors may be elected for more than two consecutive terms to the same position, except for the treasurer, who may be elected for a maximum of three consecutive terms.

corporation in permanent books for that purpose belonging to the corporation. The Treasurer shall deposit all monies and other valuable objects of the corporation in such depositories as may be designated by the Board of Directors. A written report of the finances of the corporation shall be made monthly by the Treasurer, and a report of like character shall be submitted by him/her at each annual meeting of the members. The Treasurer shall make a monthly written report of the finances of the corporation and shall prepare an annual report for the general membership meeting. He/She may be required to give such bond as the Board of Directors may designate at any time. The Board of Directors may require the Treasurer to give bond at any designated time. Bonding expenses shall be borne by the Friends of the Turlock Public Library. The books and records of the Treasurer shall be reviewed by a non-board member under the direction of the Board of Directors CPA chosen by the **Board of Directors**.
